## Investment objective & strategy

To achieve sustainable returns from a mix of different asset classes, within a tight risk controlled framework. The Portfolio can invest in a range of asset classes such as equities, bonds, commodities, absolute return funds and cash. Managed Portfolio 3 is designed to target a real return of 3% above inflation over the longer term and is aimed at investors who have a low tolerance for risk.





### Market commentary

Following the relative calm of September, the return of volatility in October helped to drive a 'risk-off' market sentiment. Amidst this backdrop, in Sterling terms all major indices posted negative returns, while government bond yields outside the US were broadly lower and gold, a classic safe-haven asset, rallied 4.2%. Despite a bounce in the final days of the month, developed market equities fell 5.3%, a smaller fall than the 6.6% decline in emerging markets. US equities declined 4.8% amid investor concerns over the durability of the economic cycle following strong economic data and comments made by the Federal Reserve indicating to the possibility for further interest rate hikes, subsequently changing the valuation basis for riskier assets. UK equities fell 4.8% with uncertainty around Brexit weighing on returns. Notably, Asian equities declined 8.2% over the month, largely attributed to the deteriorating trade war between the US and China, and mounting concern that the Chinese economy is slowing. Bond markets held up far better than equities, with some government bond markets managing small positive returns including UK Gilts, returning 1.0%. In Sterling terms, US Treasuries returned 1.7% but in US dollar terms produced a negative return of 0.5%, this can be explained by the strong US dollar which appreciated 2.1% on a trade weighted basis.
